- G-1 Discuss the role of homeland security agencies in securing ports of entry and national borders.
- G-2 Identify the challenges in border, immigration, and customs enforcement and discuss the key challenges involved with each.
- G-3 Demonstrate an understanding of the nexus between border and immigration security and the challenges of countering domestic terrorism.
