This course willfocus on advanced comprehensive physical, psychosocial, developmental, and cultural assessment of the child within the **text** of his/her family and community. Determination of the health status of children from infancy to adolescence through evaluation of a variety of data collection techniques is stressed. Analysis and interpretation of growth and development patterns are discussed as they relate to primary care. Practice sessions enable the student to refine history and physical assessment skills.
